The signee, (hereinafter called "Camper"), jointly and severally, in consideration of being permitted to enter onto, use or occupy properties or facilities belonging to or under the control of JJ'S RV RESORT and such other consideration, such consideration acknowledged as received and sufficient, does hereby agree to waive, release absolutely, indemnify and save harmless JJ'S RV RESORT, it's employees, officers, directors, contractors, volunteers and agents from and against all claims, demands, awards, judgements, costs (including legal costs), actions, causes of action and proceeding by whomever made or brought in respect of any personal injury (including death) to any person, and any loss of or damage to any property caused directly or indirectly by or as a result of the Camper, or it's family, friends, guests, acquaintances, agents, contractors, employees or any person connected with the Camper, directly or indirectly, expressly or implied, regardless of whether the Camper related person was invited or not, and regardless of whether the Camper is not at JJ'S RV RESORT.

The terms of the Agreement form shall be construed as the entire agreement and may not be altered, amended or modified except in writing and signed by all parties hereto. The terms of this Agreement shall be governed by the Laws of the Province of Alberta. This Agreement shall continue to be in full force and effect for each and every visit to JJ'S RV RESORT by the Camper, their family, friends, guest, acquaintances, agents, contractors, employees, or any person connected with the Camper, directly or indirectly, expressly or implied, regardless of whether the Camper related person was invited or not, and regardless or whether the Camper is present or not at JJ'S RV RESORT.
